**Providence Location**

**From the South**

Take **I-95 N.**  
Take **Exit 24** onto **Branch Ave.**  
Take **Right** to Branch Ave., drive to traffic light. (Fire station on the Rt.)  
Take **Right** onto **North Main St.**  
Take **Right** onto **Randall St.** (At the 2<sup>nd</sup> traffic light).  
Parking lot is on your **Left**.

**From the North**

Take **I-95 S.**  
Take **Exit 24** to the Left onto **Branch Ave.**, and then follow as above.

**From Route 146**

Take **Exit 1** onto **Admiral St.**  
Take **Left** at traffic light.  
Take **Right** onto **Ashburton St.**  
At the next traffic light,  
Take **Left** onto **Randall St.** Parking lot is on your **Right**.

**Plainville Location**

**From the South**

Take **I-95 N. to Exit 5.** Toward Route 152 Attleboro/Plainville  
Take **Left** off ramp onto **Robert Toner Blvd.** Go 0.2 mi.

Take **Left** onto **Kelley Blvd. (Rte. 152).** Continue on **Kelley Blvd. (Rte. 152)** for 3.0 mi.

Take **Left** between Honey Dew and Dunkin' Donuts onto **Man Mar Drive** go 0.2 mi, office is on the **Right, 30 Man Mar Drive Suite 2 Plainville, MA**

**From the North**

Take **I-95 S.** to **Exit 5.** Toward **Rte. 152 Attleboro/Plainville**  
Take **Left** off ramp onto **Robert Toner Blvd.** Go 0.3 mi then

Take **Left** onto **Kelley Blvd. (Rte. 152).** Continue on **Kelley Blvd. (Rte. 152)** for 3.0 mi.

Take **Left** between Honey Dew and Dunkin' Donuts onto **Man Mar Drive** go 0.2 mi, office is on the **Right 30 Man Mar Drive; Suite 2 Plainville, MA**

**From the West**

Take **I-295** to **I-95 N.**  
**Follow directions from the South.**

**From the East**

Take **I-195** to **I-95 N.**
